From I-495: Take exit 30 for Route 29 North (Colesville Road). After 2.5 miles, the road name changes to Columbia Pike. After driving about 6.5 miles on Route 29 (Colesville Road/Columbia Pike), turn left on the traffic light for Briggs Chaney Road. After turning left on Briggs Chaney Road, immediately turn right on the first traffic light for Old Columbia Pike. Within half mile, school will be on your right.

From I-95: Take exit 33 for Route 198 West towards Burtonsville. After passing US-29, turn left on the first traffic light for Old Columbia Pike. Within 2 miles, the school will be on your left.
