## **Temple Committee Update**

The temple committee has been hard at work all summer and fall in the many levels and layers of preparing the land and community for development of our new Jain Temple. In the Construction Subcommittee, Arvind Shah is leading the layout and design work with Pravin Dand and Shrenik Ajmera with preliminary plans. Site survey, topology map, and Natural Resource Inventory Forest Stand Delineation (NRI-FSD) study have been done.

We received approval of the NRI from M-NPPC of Prince George's Planning Department on October 10, 2011. Miss Utility has completed its work in identifying all utility locations on the We are in process to write a property. subcontract package for selecting Architect for our new temple design. Temple Committee chair Prakash Mehta and the attorneys have been working hard to prepare the necessary reports for submission to the county for getting needed permits. For Landscaping, Bhupesh Mehta has established a contract for the regular upkeep and beautification of the land and existing home. In Communication and Public Relations, Sushil Jain and team have been arranging meetings with local, school and government officials to update regarding development plans. Further, they are planning to set up events with local and school officials to introduce the Jain Society to new neighborhood. The Fundraising subcommittee led by Manoj Dharamsi thanks all members for their generous pledge for the new temple and requests those who have not yet pledged to please send their pledges for this noble cause.

We have used our Jain Society funds to pay off the closing cost of purchasing the two adjacent land parcels (total of about 5.5 acres), and need funds to proceed with the site work, getting county approval for building our temple at the new location, preparing architectural drawings for submission to the county for final plan and more. A number of members have sent donation of more than half of their pledge, and we are requesting all members to donate more than half of their pledge this year.

The temple committee also has worked together to develop committee operating guidelines. Finally, the chair, Prakash Mehta, and subcommittee leads are developing an overall budget for the temple project. After preparing the draft architectural plans, a special general body meeting will be held to get feedback from all members before finalizing the plans. # **Constitution Committee Update**

We have now come to the final stage of presenting the revised constitution and bylaws to the General Body for comments. A big thank you to Pavan Zaveri for doing a yeomen's task. We have collected and reviewed some 15 different bylaws of our sister organizations. We also reviewed articles on how to write the bylaws. We have posted current constitutions and bylaws of larger as well as smaller Jain Societies throughout USA as well as other likeminded non-profit organizations in the Washington Metro area. All these documents are now available as "Google Docs files" and everyone on the Constitution Committee has been provided access to these documents for reference purposes. If anyone from our membership is interested in reviewing these documents, please get in touch with me.

We have used a very deliberate and transparent process to begin our revision. The starting point was our original draft revision done some many years ago. In the current process, we have actually gone further and reviewed the bylaws of other sister or like-minded organizations and have tried to identify the gaps, issues and shortcomings in our current bylaws. We started our revision with a detailed outline of what we wanted to include in our revised bylaws. To give due credit to our founding fathers; we have kept the structure of the revision process discrete and to preserve as much of the original work as we could. So, there was no wholesale replacement or process to re-write the bylaws. Rather, we have looked at the gaps, issues, short comings and what has transpired in the last 30 plus years in our Society to bring our bylaws to the current way of doing the things we do. The revised Constitution has 16 Articles. The articles on Executive Committee and Board of Trustees addresses qualifications, duties, term lengths and limits and more clearly defines the roles of the members of the Executive Committee well the Board as as Trustees. Additionally, we have clarified who are the voting members of the Society and have institutionalized the Committee structures to identify Standing and Ad Hoc Committees and more clearly laid out the election process as well as clarifying the role of Nominations & Election Committee.

To keep the process moving and to stay with our desire to present the revised bylaws at the next General Body Meeting, we now have tried to address all issues we had put on the back burner as we were revising the constitution so that we could have a complete document to present to the General Body. The Executive Committee has met three times to review the draft that was presented to them and we have tried to address all issues and concerns that were brought forward by the Executive Committee. The constitution committee has now also met three times and, after much deliberation, come up with a document that we will be presenting at General Meeting. Body

#### RULES AND REGULATIONS FOR ELECTIONS

#### 1. POSITIONS

The nomination form may be filled for any one of the following 16 positions.

**Board of Trustees:** Trustees for a term of 2 years.

Executive Committee: President, Vice-President, Secretary, Joint-Secretary, Treasurer, Joint-

Treasurer, and three members-at-large for a term of one year.

**Youth Committee:** Coordinator, and four members for a term of one year.

#### 2. RESTRICTIONS

Only members with voting rights are eligible for contesting for election. A voting member can submit a nomination form for only one position. Only one member of a member family can contest for any one position in the Executive Committee since the constitution does not allow more than one person of the same family in the Executive Committee. The same rule applies to the Board of Trustees as well as to the Youth Committee. No officer of the Executive Committee (President, Vice President, Secretary, Joint Secretary, Treasurer and Joint Treasurer) can apply for election to the same office for more than three consecutive terms.

#### 3. VOTING RIGHTS

Husband, wife, their parents and unmarried children of minimum age of 18 years, living in the same household, are entitled to vote at the general body meeting, and also for the election of the Board of Trustees and the Executive Committee. The constitution states that members' married children are not treated as members of the Jain Society, unless and until they become separate members of the Jain Society. As such, married children are not eligible for voting or contesting for election because of the membership of their parents.

Members' unmarried children of age 15 to 25 years, as well as, members of age 15 to 25 are entitled to vote for the election of the Youth Committee. The age requirement must be satisfied on the 1st January of the year for which the elections are being held.

#### 4. ELIGIBILITY REQUIREMENTS FOR CANDIDATES

**Board of Trustees**: To be eligible for election to the Board of Trustees, a person must be a life member of the Society for at least one year prior to 1st January of the election year, and must have paid a minimum of \$5,000 donation for Jain Center (does not include payments for Gheebolis, membership fees or charges for programs or other services) prior to the nomination deadline for the elections.

**Executive Committee**: To be eligible for election to the Executive Committee, a person must be a member of the Society for one year prior to 1st January of the election year.

**Youth Committee**: Coordinator shall be of age 18 years and over, and committee members shall be of age 15 to 25 years, on the 1st January of the election year.

#### 5. ELIGIBILITY REQUIREMENT FOR NOMINATORS

A person who is eligible for voting for the election of a position is eligible for nominating a candidate for that position.
