Fund Raising:

Under the leadership of Dr. Gita Shah, a group of young volunteers are meeting twice every week in an effort to develop a comprehensive Fundraising strategy draft for our review and approval. We have received a little over \$1 Million, according to our preliminary calculations. Our total project cost is estimated to be approximately \$7.5 Million. The Fundraising strategy will soon be announced to the General Body.

In addition, they expressed concerns over the lack of communication or miscommunication. The speed & success of our project is also dependent on the support and cooperation we receive from our neighbors. To facilitate this, we will be launching several community service projects in the near future. The details for these will be announced once planned.

In addition, there are numerous tasks that have been accomplished. To name a few; Feasibility Study Report, NRI_FSD Study, Traffic Study, legal formalities of demolition of existing structures at site etc. have been completed. We would kindly urge all of you to join this effort in whichever way you can to make this a successful effort that will be remembered and admired by future generations to come.

Class B and C - 1st Prize - Dilan Gangar - Ahimsa

Ahimsa is the basic teaching of Jainism. The purpose of this lesson is not to harm any living being in any way (nonviolence). Violence can be used in thoughts, words and actions.

Violence affects me in my everyday life. For example, people step on bugs in school. So, I will limit stepping on grass because there are living beings on the grass. I tell my friends not to step on them. When people see arguments they usually chant “fight, fight, fight”, which encourages violence. When people encourage violence they can build up bad karma.

Violence is mostly used in a physical way, when I become angry, sometimes I get into a fight with my brother. Our fight includes baleful words and hurtful actions, such as punching. This does not follow the rule of Ahimsa. Mahatma Gandhi once said, “An eye for an eye makes the whole world blind”. If I fight I will take deep breaths and apologize even if I didn’t do anything wrong. After I calm down I will ask for forgiveness to make peace between the person/people

Whenever I hear about any wars I feel saddened that people risk their lives by resorting to violence instead of resolving it with words. A non-violent way to settle conflict is to either protest or compromise with one another. Sometimes families lose relatives such as parents or

I think Ahimsa is one of the most important of the 5 main vows. This teaching prevents violence towards any living being, including animals, which is why I’m a vegetarian. It’s a tragedy that people have to kill animals to feed themselves even there are healthier foods to eat, such as fruits and vegetables. To me, Ahimsa is extremely important since I use it in my everyday life by

Ahimsa is one of the most important principles in Jain religion. All supreme beings practice Ahimsa in many ways to help the environment. I think practicing Ahimsa can lead the world to peace and harmony.

Class D, E and G - 1st Prize - Kanvi Shah - “Break it Down, and Cleanse the Soul”

“The ultimate goal of Jainism is to end this cycle of birth, death, and rebirth, by shedding all of your karma.” This simple sentence carries the weight of Jainism, explaining the entire point of a whole religion. But how can that be? It doesn’t say anything about being vegetarian or not killing bugs; honestly, if I didn’t know better, I would just think someone stuck a bunch of words together and made it sound good. Thankfully, I do know better. And it’s not so bad once you break it down.

Growing up in a culture where everyone’s different can be amazing, but at the same time a struggle. Surrounding us are people from hundreds of different backgrounds, and growing up with the same principles our parents did is difficult.

A question that most Jains living outside of India have been asked is the famous, “Why don’t you eat meat?” The famous question has a famous answer, a variation of the statement, “It’s because of my religion,” which is pretty much a tool to just brush off the question and push it away. To me, that question should be treated as if it were an opportunity; a chance to explain a certain aspect of

Jainism: one of the best known and acted upon, Ahimsa (non-violence).

As one of the five great vows (Mahavrats) as well as a part of the Atichar’s vows of limited nature (Anuvratas), it deserves more than a place on side.

Ahimsa is a powerful instrument in all Jains’ lives, and in mine, it’s how I give back to the world that has given me everything I have. Every life I save, every soul I refuse to harm impacts me in a way that I cannot scientifically describe. But as a Jain, I have a spiritual way to explain it. Each time I perform a life-saving act, my soul becomes a little purer, as I gain good karma for my good deed. In my life, the clarity of knowing the reason I refrain from violence.....
